Marina General Rules and Regulations

These rules and regulations are intended to ensure the safe and enjoyable use of the marina. Non-compliance with these rules and regulations could result in expulsion from the marina, with no refund of fees.

- The overall length shall be the measurement from the extreme point of the bow to the extreme point on the stern, including all gear and appurtenances. Charges based on length of pontoon or boat whichever is longer.
- Berthing fees must be paid in advance. Refundable deposits will be imposed for longer terms.
- Vessel occupying more than 50% of the width of a double-berth and vessel operating commercially will be charged twice the prevailing rate.
- Above fees is inclusive of port & harbour taxes/dues with Terms & Conditions apply.
- Restaurant / miscellaneous bills to be paid weekly basis or before departure whichever is early.
- Utilities bills to be paid monthly basis or before departure whichever is early.
- Boat must be insured to be operated in Indonesian waters, against loss, damage, fire, third-party and other liabilities.
- Boat must be fitted with working IMO approved AIS Class A/B. MMSI certificate & AIS must match.
- Boat owners, Captains, their crew or guests are cautioned to be considerate of others. Discourteous conduct or disorder that might injure a person, cause damage to property, disturb other tenants or harm the reputation of the Marina/Resort will not be tolerated.
- Pets are permitted only if they DO NOT disturb others. Pets must be kept on a leash and under control at all times. Owners are responsible for cleaning up after pets. Noncompliance will result in the owner not being permitted to have any pets within the Marina/Resort.
- Pontoons must be kept clean, free and clear of stored materials.
- The Management reserves the right to review and revise all rates / prices without prior notice.
